ARTICLES OF INCORPORATION

OF WOODLANDS EAST HOMEOWNER'S ASSOCIATION, INC.

The undersigned hereby associate themselves for the purpose of forming a corporation not for profit under Chapter 617, Florida Statutes, and certify as follows:

ARTICLE I

CORPORATE NAME

The name of this corporation is WOODLANDS EAST. HOMEOWNER'S ASSOCIATION, INC., hereinafter referred to for convenience as "ASSOCIATION".

ARTICLE II

PURPOSE

The purpose for which the ASSOCIATION is organized is to provide an entity to which can be, and will be delegated and assigned the powers necessary and proper to maintain and administer the common properties and facilities of the WOODLANDS EAST development which is presently being developed and is to be developed on real property located in Seminole County, Florida, and further to administer and enforce the provisions of the Declaration of Covenants, Conditions and Restrictions for WOODLANDS EAST Subdivision which restrictions are herein referred to as Declaration of Covenants and Restrictions, as the same now exist or may hereafter from time to time be amended. The ASSOCIATION does not contemplate pecuniary gain or profit, direct or indirect, to its members and the ASSOCIATION shall make no distribution of income to its members, directors or officers.

ARTICLE III

POWERS

The powers of the ASSCCIATION shall include and be governed by the following provisions:

- 3.1 The ASSOCIATION shall have all of the common law and statutory powers of a corporation not for profit which are not in conflict with these Articles and the Declaration of Covenants and Restrictions.
- 3.2 The ASSOCIATION shall have all of the powers and duties provided to the ASSOCIATION in the Declaration of Covenants and Restrictions except as limited by these Articles, and all the powers and duties reasonably necessary to operate and administer the common properties and facilities of the WOODLANDS EAST development and to administer and enforce the provisions of the Declaration of Covenants, Conditions and Restrictions, pursuant to its terms as presently drafted and as may be amended from time to time, including but not limited to the following:
- a. Assess To make and collect assessments against members as owners in said development to defray the costs, expenses and losses of the Association.
- b. <u>Disburse</u> To use the proceeds of assessments in the exercise of its powers and duties.
- c. Maintain To maintain, repair, replace and operate the common properties and facilities, and to cause such exterior maintenance and repairs to be performed as may be necessary upon parcels subject to the assessments, as provided in the above-referenced Declaration of Covenants and Restrictions.
- d. <u>Insure</u> To purchase insurance upon common properties and insurance for the protection of the Association and its members as unit owners.
- e. <u>Reconstruct</u> To reconstruct improvements on the common properties after casualty and to further improve the common properties, as provided in the Declaration of Covenants and Restrictions.
- f. Regulate To make and amend reasonable regulations respecting the use of the common properties in the development.
- g. Borrow Money To borrow money for the purpose of improving the common properties, and in aid thereof to mortgage

said properties, and to take steps as are reasonably necessary to protect said common properties against foreclosure. Any mortgage of common properties shall require the assent of two-thirds (2/3) of each class of membership.

- h. <u>Dedicate</u> To dedicate or transfer all or any part of the common properties to any public agency, authority or utility for such purposes and subject to such conditions as may be agreed to by the members, provided, however, that no such dedication of transfer, determination as to to the purposes or as to the conditions thereof, shall be effective unless an instrument signed by members entitled to cast two-thirds (2/3) of the votes of each class of membership has been recorded, agreeing to such dedication, transfer, purpose or condition, and unless written notice of the proposed agreement and action thereunder is sent to every member at least thirty (30) days in advance of any action taken.
- i. <u>Enforce</u> To enforce by legal means the provisions of Declaration of Covenants and Restrictions referred to above, and regulations for the use of the common properties as may be promulgated from time to time by the Association.
- j. <u>Employment</u> To employ personnel for reasonable compensation to perform the services required for proper administration of the purposes of the ASSOCIATION.
- k. Payment of Liens To pay taxes and assessments which are liens against any part of the common properties of the development, and to assess the same against the individual parcel owners in said development.
- 1. <u>Utilities</u> To pay the cost of all power, water, sewer and other utility services rendered to the common properties and not billed to owners of individual parcels in the development.
- m. <u>Suspend Rights</u> To suspend the right to use and enjoy the common properties and facilities of any member for any period during which any assessment shall remain unpaid, and for any period not to exceed thirty (30) days for any infraction of the published rules and regulations of the Association.

n. Other To do such other things as may be necessary in order to perform the functions and exercise the powers provided to be exercised by the Association by the above-referenced Declaration of Covenants and Restrictions of WOODLANDS EAST in order to effect the purpose and intent of said Declaration.

ARTICLE IV

MEMBERS AND VOTING RIGHTS

- 4.1 Every person or entity who is a record owner of a fee or undivided fee interest in any parcel which is subject by covenants of record to assessment by the ASSOCIATION shall be a member of the ASSOCIATION, provided that any such person or entity who holds such interest merely as a security for the performance of any obligation shall not be a member.
- 4.2 Change of membership in the ASSOCIATION shall be established by recording in the Public Records of Seminole County, Florida, a deed or other instrument establishing a record title to a parcel in the development. The owner designated by such instrument thus becomes a member of the ASSOCIATION and the membership of the prior owner is terminated.
- 4.3 The ASSOCIATION shall have one class of voting membership:
- a. Class A class A members shall be all those owners as defined in Section 4.1. Class A members shall be entitled to one vote for each parcel in which they hold the interests required for membership by 4.1. When more than one person holds such interest or interests in any parcel, all such persons shall be members and the vote for such parcel shall be exercised as they, among themselves, determine but in no event shall more than one vote be cast with respect to any such parcel.

ARTICLE V

DIRECTORS

- 5.1 The affairs of the ASSOCIATION shall be managed by a Board of Directors consisting of no less than three (3) Directors.
- 5.2 Members of the Board of Directors shall be elected at the annual meeting of the ASSOCIATION members in the manner specified in the By-Laws. Directors may be removed and vacancies on the Board of Directors shall be filled in the manner provided by the By-Laws.
- 5.3 The first election of Directors shall be held at the first annual meeting of the members which shall be held within three (3) months from the date of the filing of these Articles of Incorporation. The Directors named in these Articles shall serve until the first election of Directors, and any vacancies in their number occurring before the first election shall be filled by the remaining Directors.
- 5.4 The names and addresses of the present members of the Board of Directors, who shall hold office until their successors are elected and have qualified, or until removed, are as follows:

ARTICLE VI

OFFICERS

The affairs of the ASSOCIATION shall be administered by the officers designated in the By-Laws. The officers shall be elected by the Board of Directors at its first meeting following the annual meeting of the members of the ASSOCIATION, and they

shall serve at the pleasure of the Board of Directors. The names and addresses of the officers who shall serve until their successors are designated by the Board of Directors are as follows:

ARTICLE VIII REGISTERED OFFICE

The street address of the initial registered office of this corporation is 650 Douglas Road, Altamonte Springs, Florida 32714, and the name of the initial registered agent of this corporation at that address is ELLSWORTH G. GALLIMORE. Such office and registered agent may be changed from time to time by action of the Board of Directors.

ARTICLE IX

INDEMNIFICATION

Every Director and Officer of the ASSOCIATION shall be indemnified by the ASSOCIATION against all expenses and liabilities, including counsel fees, reasonably incurred by or imposed upon him in connection with any proceeding or settlement of any proceeding to which he may be a party or in which he may become involved by reason of his being or having been a Director or Officer of the ASSOCIATION, whether or not he is a Director or Officer of the ASSOCIATION at the time such expenses are incurred, except as in such cases wherein the Director or Officer is adjudged guilty of willful misfeasance or malfeasance in the performance of his duties; provided, that in the event of a

settlement, the indemnification herein should apply only when the Board of Directors approves such settlement and reimbursement as being for the best interests of the ASSOCIATION. The foregoing right of indemnification shall be in addition to and not exclusive of all rights to which such Director or Officer may be entitled.

ARTICLE X

DURATION

The term of the ASSOCIATION shall be perpetual, unless otherwise sooner terminated.

ARTICLE XI

BY-LAWS

The First By-Laws of the corporation shall be adopted by the Board of Directors and may be altered, amended, or rescinded in the manner provided by the By-Laws.

ARTICLE XII

MERGERS AND CONSOLIDATIONS

Subject to the provisions of the recorded covenants and restrictions applicable to the properties described in Article II and to the extent permitted by law, the ASSOCIATION may participate in mergers and consolidations with other non-profit corporations organized for the same purpose, provided that any such merger or consolidation shall require two-thirds (2/3) vote of members who are voting in person or by proxy, at a meeting duly called for this purpose, written notice of which shall be mailed to all members at least thirty (30) days in advance and shall set forth the purpose of the meeting.

ARTICLE XIII

AMENDMENTS

Amendments to the Articles of Incorporation shall be proposed and adopted in the following manner:

13.1 Notice of the subject matter of a proposed amendment shall be included in the notice of any meeting at which a proposed amendment is considered.

- amendment may be proposed either by the Board of Directors or by twenty-five per cent (25%) of the members of the ASSOCIATION.

 Directors and members not present in person or by proxy at the meeting to consider the amendment may express their approval in writing, provided such approval is delivered to the Secretary prior to such meeting. A resolution adopting a proposed amendment must bear the approval of not less than seventy-five per cent (75%) of the members of the ASSOCIATION.
- 13.3 No amendment shall make any changes in the qualifications for membership nor the voting rights of members without approval in writing by all members and the joinder of all record owners of mortgages upon the properties. No amendment shall be made that is in conflict with the Declaration of Covenants, Conditions and Restrictions, as amended, or the laws of the State of Florida.
- 13.4 A copy of each amendment shall be certified by the Secretary of State, State of Florida.
